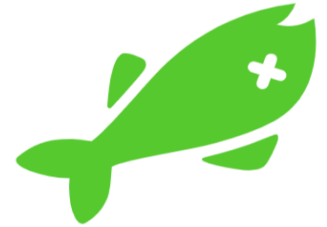
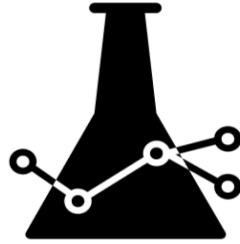

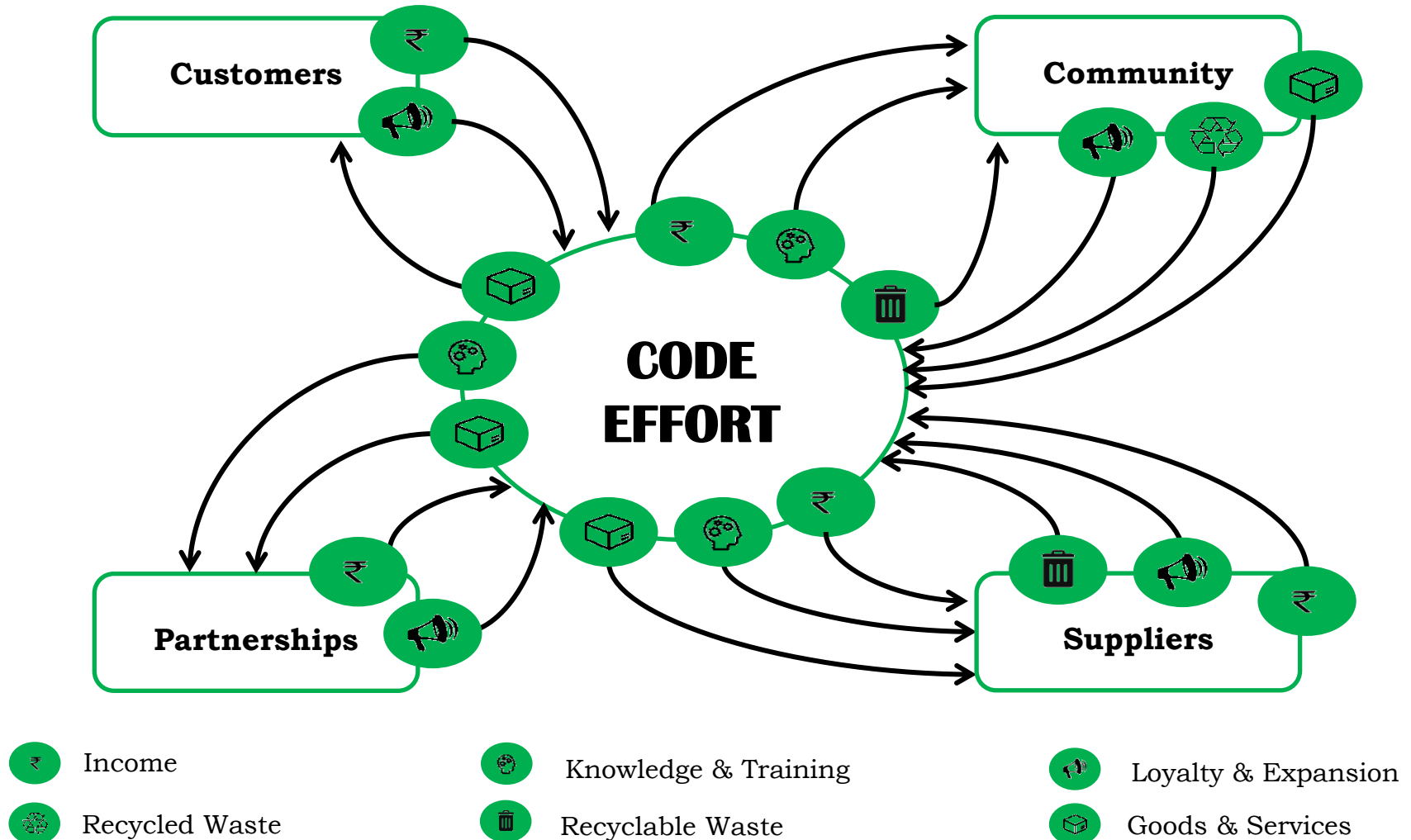

**Separated used** cigarette butts are the cigarette butts that are collected and further disintegrated manually into leftover paper, tobacco, and polymer.

- The procured supply will be rejected and resent at association's expense in case the supply includes any unwanted contents like bidi, matchsticks, mud, ash, moisture, stones, polybags, metal, glass, industrial cigarette waste, unused cigarette waste, illegal or hazardous articles, other waste, etc.
- Cigarette waste supply must be done only after separation of non-separated cigarette butts from unwanted substances, ash and tobacco into different packages in appropriate ratio as well as labelling (payment will be calculated for 90% of the procured quantity after inspection only).
- Cigarette waste supply must be done only after separation of polymer, leftover paper and tobacco into different packages in appropriate ratio as well as labelling [{Polymer 58%}: {Paper 40%}: {Tobacco 2%}] (payment will be calculated for the appropriate ratio cumulatively only)].
- Each cigarette butt weighs between 0.3 to 0.6 grams.
- Payment will be calculated after inspection of the procured quantity transported via door-to-door courier service(s) attached with a signed association's declaration and true and fair retail invoice only till the recycling unit of Code Effort Private Limited.
- Supply will be considered ZERO if the waste is found WET at the time of supply inspection and the payment will be considered ZERO.
- Payment for the supplied cigarette waste, if any will remain due or considered ZERO in case of no by-product purchases and sales per month per district mentioned in the attached registration form or invoice as well as failure in monthly compliance with any scope and manner of services.
- Payment will be done via bank transfer after 200 working hours only after inspection of the procured quantity if all scope and manner of services as well as terms of use comply and satisfy respectively.
- Renewal of contract is subject to charges and changes without prior notice since quarterly amendment(s) are made as per calendar year to maintain business growth and foster smooth functioning of Code Effort Private Limited.
