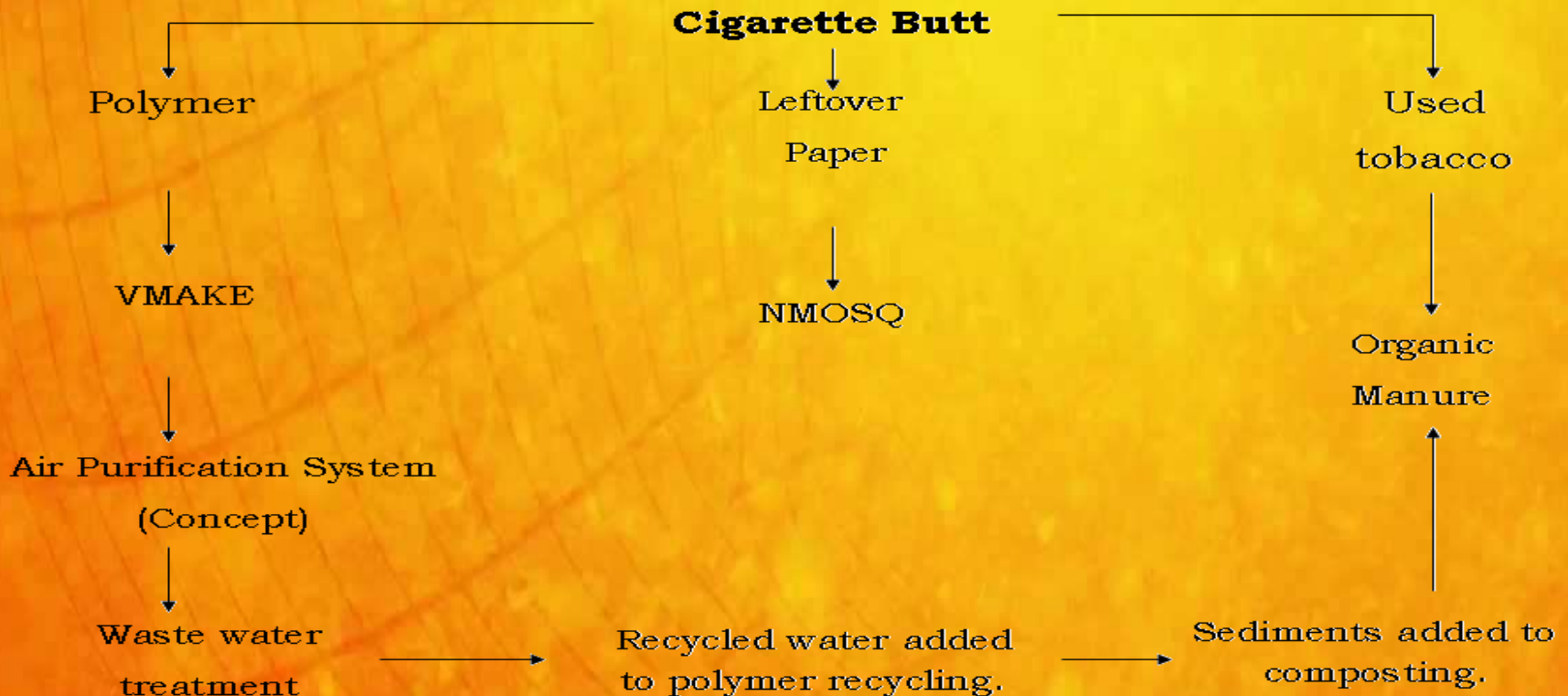
Cigarette butts were invented in 1960- 1970 as a promotional feature by the cigarette manufacturers which was later made mandatory due to various reasons. The filter (cellulose acetate) is a type of plastic which has multiple uses.

In India, **no specific guidelines or regulations** are available for appropriate cigarette waste management and recycling. Also, there was no cigarette waste management and recycling organization before the **inception of Code Effort Private Limited in 2018.**

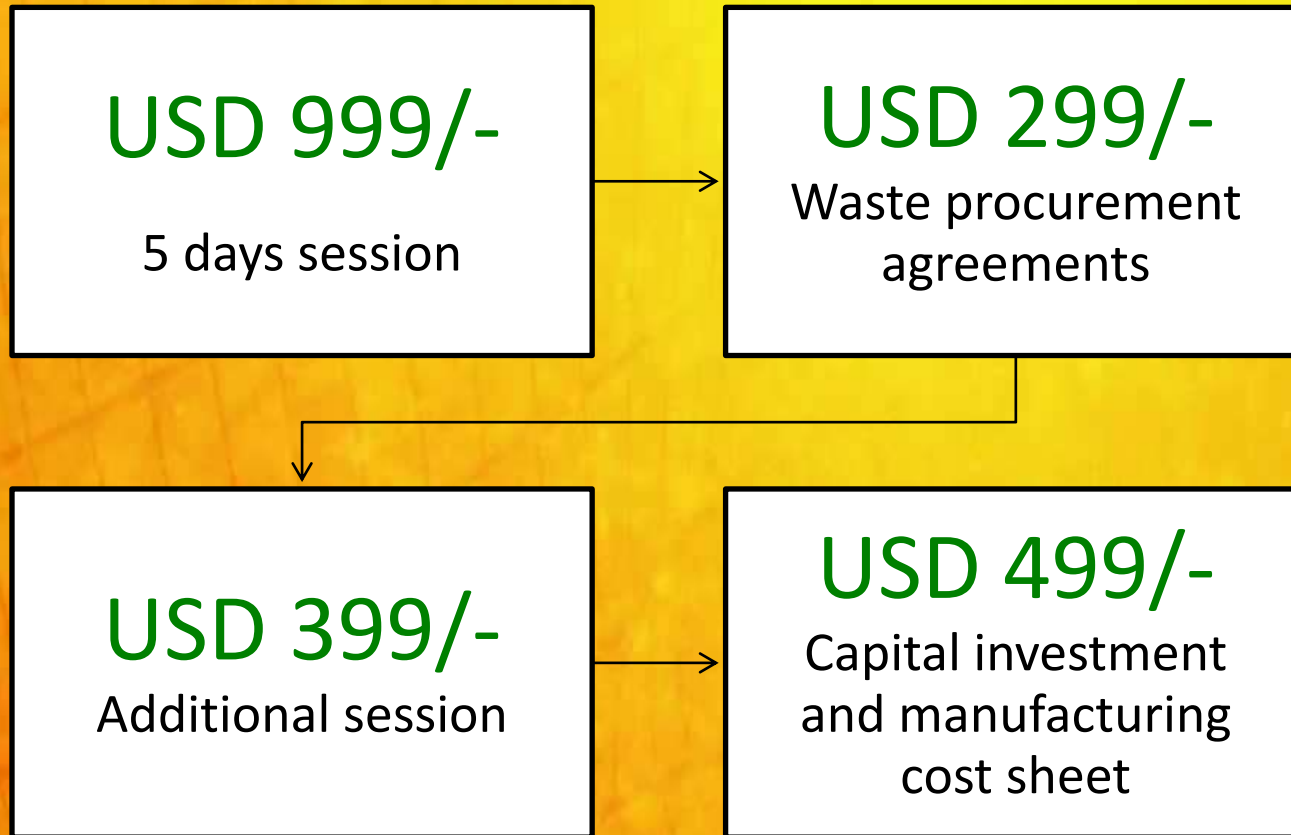
